5. General directions for use

5.1. Instructions for use

Comply with the instructions for use. Ensure that no lice are present. First use a pediculicide if needed. The product repels only new infestation After application, this product repels head lice up to 24 hours. Apply every morning on clean and towel dried hair after styling it in the usual way. Spray the product on the hair close to the scalp (between 2-5 cm) on the totality of the hair like a lacquer. Be sure to cover all the hair, paying particular attention to the areas close to the neck and behind the ears. Make sure that the scalp and hair are sufficiently moistened. Allow the hair to dry naturally without applying heat. Do not use a hairdryer. The application must be repeated after washing the hair. Suitable for use by adults and children as of 2 years and older. Inform the registration holder if the treatment is ineffective.

5.2. Risk mitigation measures

For external use only. When spraying indoor, make sure the room is well ventilated and avoid breathing in spray. Do not spray in eyes. Avoid contact with eyes, mucous membranes, nose, lips and damaged skin. For application on children's hair, the product is to be applied by an adult. The product is not intended for use on animals/pets. Do not apply when animals/pets are present. Avoid breathing vapours/spray. Use only outdoors or in a well-ventilated area.

5.3. Particulars of likely direct or indirect effects, first aid instructions and emergency measures to protect the environment

If medical advice is needed, have product container and label at hand. First aid instructions:

IF SWALLOWED: Rinse mouth. Give something to drink, if exposed person is able to swallow. Do NOT induce vomiting. Call a POISON CENTRE or a doctor.

IF IN EYES: Rinse with water. Remove contact lenses, if present and easy to do. Continue rinsing for 5 minutes. Call a POISON CENTRE or a doctor.

IF ON SKIN: If irritation occurs wash with water and seek medical advice. In cases of unintentional kin exposure: wash with water. IF INHALED: If symptoms occur call a POISON CENTRE or a doctor.

Methods for cleaning up/taking up: Adsorb onto sand, earth or a similar adsorbent material. Transfer to a container for disposal. Dispose of absorbed material in accordance with the regulations.

5.4. Instructions for safe disposal of the product and its packaging

Do not reuse the packaging and do not dump the product/packaging into the environment. Must not be disposed of together with household garbage. Do not allow product to reach sewage system.

5.5. Conditions of storage and shelf-life of the product under normal conditions of storage

Keep out of reach of children and non-target animals/pets. Protect from frost.
