

# Minutes of the 85<sup>th</sup> Meeting of the Member State Committee (MSC-85)

## Summary Record of the Proceedings and Conclusions and action points

The Chair, Katinka van der Jagt, welcomed all participants to the 85<sup>th</sup> MSC meeting with remote participation. The Chair mentioned a few highlights of the meeting, including one testing proposal evaluation (under Dossier evaluation), the MSC opinion on the update of the CoRAP and a status update on the draft for the 12<sup>th</sup> Annex XIV recommendation.

#### Session 1 & 2 (open & closed)

A representative of the Registrant joined the meeting to follow the initial discussion. In absence of specific confidentiality concerns in the DD, an open session was held followed by discussion and voting in closed session.

ECHA Secretariat (SECR) introduced the proposals for amendment (PfAs) that required discussion in the meeting. The PfAs suggested to include Cohort 3 (developmental

immunotoxicity, DIT) in the extended one-generation reproductive toxicity study. The proposals were justified by available data on the Substance:

- mechanism/mode of action with 1) specific an association to DIT, namely estrogenic/androgenic/steroidogenic (EAS) mode of action or sex steroid-related potential, observed in vitro and in vivo in fish and rats;
- 2) immunotoxicity, namely thymus epithelial cell proliferation;
- 3) arguments 1 and 2 combined.

SECR had not modified the draft decision before the meeting, awaiting discussion in the meeting. The Registrant had not submitted written comments on the PfAs.

MSC discussed the relevance of the available data.

MSC acknowledged that the evidence raised in the PfAs is sufficient to indicate that the Substance may have EAS activity in rats in vivo.

MSC also acknowledged that the evidence raised in the PfAs shows histopathological effects in thymus.

MSC held that both arguments, independently, satisfy the column 2 conditions (Annex X, section 8.7.3.) for triggering the DIT cohort.

#### Discussion outcome:

MSC concluded that the evidence presented in this case justifies inclusion of the DIT cohort in EOGRTS. MSC agreed to modify the draft decision in line with the arguments presented in the PfAs. Finnish member abstained from voting.

The MSC reached unanimous agreement on the SECR to upload on Interact the agreed following ECHA draft decision as modified at decision in the respective case agenda the meeting:

#### Item 9 - ECHA's recommendations of priority substances to be included in Annex XIV and opinion of MSC

Short status update on the 12th draft recommendation

SECR gave a short status update regarding the draft 12th recommendation for inclusion of substances into Annex XIV. In its presentation SECR summarised the comments received from MSC and responded to the written comments received since the previous meeting. Following the feedback and further considerations Bis(2-ethylhexyl) tetrabromophthalate was included by SECR as the fifth substance to the draft recommendation. SECR informed MSC that the consultation of interested parties was launched on 7 February and will run until 7 May 2024. In its June meeting MSC may expect to hear some highlights of the comments received and will also need to appoint a Rapporteur to draft its opinion.

MSC took note of the progress and next steps. **SECR** to provide some highlights from the comments received at MSC-86.

#### Item 10 - ECHA's draft update of the Community Rolling Action Plan and opinion of **MSC**

The MSC Rapporteur presented the draft opinion of MSC on ECHA's draft update of the Community Rolling Action Plan for (CoRAP 2024-2026)

The update included 11 new substances for evaluation. One substance was withdrawn from the Coral. In the discussion an observer raised that having the majority of new substances allocated for evaluation already for 2024 will not allow industry to update their registrations. SECR took note and will consider how to accommodate this in future updates. MSC supported the addition of these 11 new substances to the CoRAP update and the one withdrawal.

MSC adopted by consensus the opinion and its MSC-S to upload the MSC CoRAP opinion Annex on the draft CoRAP update 2024-2026 including its annex on MSC Interact by 19 February 2024.

#### Item 11 - Any other business

1. Presentation on the Commission NAM workshop of December 2023 and the ongoing work of Commission on the non-animal testing roadmap

Under this agenda item the MSC was introduced to the Commission's Roadmap towards phasing out animal testing for chemical safety assessment. The roadmap is expected to address all relevant pieces of chemicals legislation (e.g. REACH, Biocidal Product Regulation, Plant Protection Products Regulation and human and veterinary medicines). It is to be considered as a policy document and will include the interim steps and actions that would be needed. It was explained that the workshop that was held in December 2023 [recordings and presentations available on COM website] contributes to developing the roadmap, and a second one is already planned for the second half of 2024. Communication, outreach and involvement of stakeholders were mentioned as key elements of the roadmap, together with an action plan and acceleration of validation and regulatory acceptance of non-animal testing. The roadmap is expected to be finalized by the beginning of 2026. Some comments and clarifying questions were raised in the discussion.

2. Updates on appeals and court cases of relevance to MSC

SECR gave an overview of pending appeal and court cases and recent judgements on Evaluation and SVHC identification in open session. Also an overview of litigation in 2023 was provided, together with some highlights from the past year.

3. Update on PARC

SECR provided a short update on the project Partnership for the Assessment of Risks from Chemicals (PARC), highlighting the relevance of several of its projects to MSC. SECR also invited input from MSC as regards research areas that should be further developed or where regulatory challenges might be an issue.

MSC took note of the presentation.
