Acetic acid, lead salt, basic is covered by Index number 082-001-00-6 in Regulation (EC) No 1272/2008 and classified in Annex VI, part 3, Table 3.1 (list of harmonised classification and labelling of hazardous substances) as toxic for reproduction, Repr. 1A (H360D: "May damage the unborn child"). The corresponding classification in Annex VI, part 3, Table 3.2 (the list of harmonised and classification and labelling of hazardous substances from Annex I to Directive 67/548/EEC) of Regulation (EC) No 1272/2008 is toxic for reproduction, Repr. Cat. 1, R61 ("May cause harm to the unborn child").

Therefore, this classification of the substance in Regulation (EC) No 1272/2008 shows that it meets the criteria for classification as toxic for reproduction in accordance with Article 57 (c) of REACH.
