DECISION ON A COMPLIANCE CHECK OF A REGISTRATION PURSUANT TO ARTICLE 41(3) OF REGULATION (EC) NO 1907/2006

For Reaction mass of 2,2'-(Ethylenedioxy)diethanol and 3,6,9-Trioxaundecane-1,11-diol, EC No 907-131-0, registration number:

The European Chemicals Agency (ECHA) has taken the following decision in accordance with the procedure set out in Articles 50 and 51 of Regulation (EC) No 1907/2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH Regulation).

I. <u>Procedure</u>

Pursuant to Article 41(1) of the REACH Regulation ECHA has performed a compliance check of the registration for Reaction mass of 2,2'-(Ethylenedioxy)diethanol and 3,6,9-Trioxaundecane-1,11-diol, EC No 907-131-0, submitted by (Registrant).

The scope of this compliance check decision is limited to the standard information requirements of Annex VII, Section 7.8. of the REACH Regulation. ECHA stresses that it has not checked the information provided by the Registrant and other joint registrants for compliance with requirements regarding the identification of the substance (Section 2 of Annex VI).

This decision is based on the registration as submitted with submission number, for the tonnage band of 1000 tonnes or more per year. This decision does not take into account any updates submitted after 4 September 2014, the date upon which ECHA notified its draft decision to the Competent Authorities of the Member States pursuant to Article 51(1) of the REACH Regulation.

This compliance check decision does not prevent ECHA from initiating further compliance checks on the present registration at a later stage.

The compliance check was initiated on 27 March 2014.

On 16 June 2014 ECHA sent the draft decision to the Registrant and invited him to provide comments within 30 days of the receipt of the draft decision.

On 11 July 2014 ECHA received comments from the Registrant agreeing to ECHA's draft decision.

The ECHA Secretariat considered the Registrant's comments. The information is reflected in the Statement of Reasons (Section III) whereas no amendments to the Information Required (Section II) were made.



On 4 September 2014 ECHA notified the Competent Authorities of the Member States of its draft decision and invited them pursuant to Article 51(1) of the REACH Regulation to submit proposals for amendment of the draft decision within 30 days of the receipt of the notification.

As no proposal for amendment was submitted, ECHA took the decision pursuant to Article 51(3) of the REACH Regulation.

II. <u>Information required</u>

Pursuant to Articles 41(1), 41(3), 10(a)(vi) and/or (vii), 12(1)(e), 13 and Annex VII of the REACH Regulation the Registrant shall submit the following information using the indicated test method and the registered substance subject to the present decision:

• partition coefficient n-octanol/water (Annex VII, 7.8.; using an appropriate test method)

Pursuant to Articles 41(4) and 22(2) of the REACH Regulation the Registrant shall submit the information required by this decision in the form of an updated registration to ECHA by **1 June 2015**.

III. Statement of reasons

Pursuant to Article 41(3) of the REACH Regulation, ECHA may require the Registrant to submit any information needed to bring the registration into compliance with the relevant information requirements.

Pursuant to Articles 10(a)(vi) and/or (vii), 12(1)(e) of the REACH Regulation, a technical dossier for a substance manufactured or imported by the Registrant in quantities of 1000 tonnes or more per year shall contain as a minimum the information specified in Annexes VII to X of the REACH Regulation.

"Partition coefficient n-octanol/water" is a standard information requirement as laid down in Annex VII, Section 7.8. of the REACH Regulation. Adequate information on this endpoint needs to be present in the technical dossier for the registered substance to meet this information requirement.

The technical dossier does not contain relevant data to fulfil this information requirement. The Registrant sought to adapt the information requirement, but did not provide a sufficient justification. The Registrant states that "the partition coefficient n-octanol / water (Pow) of the test item cannot be determined according to OECD Guideline 107 because the test item is a multi-component mixture. Also the determination according to OECD Guideline 1 I 7 (HPLC method) is not possible, because the test item is not feasible for the HPLC method" and that "as the test item is miscible in any ratio in water and in noctanol as well, the log Pow of the test item can not even be estimated from the single solubilities in water and in n-octanol".

The registered substance is a multi-constituent substance with two main constituents which are not expected to behave very differently or interfere in the results and thus, it is not justified why the partition coefficient n-octanol/water cannot be determinded according to OECD TG 107. Also, the Registrant has not provided a sound scientific justification as to why the test is not feasible according to OECD TG 117. In addition, in accordance with Column 2 of Annex VII, Section 7.8. of the REACH Regulation, when the test cannot be performed a



calculated value for Log Kow as well as details of the calculation method shall be provided. The Registrant has not provided a calculated value.

As explained above, the information available on this endpoint for the registered substance in the technical dossier does not meet the information requirement. Consequently there is an information gap and it is necessary to provide information for this endpoint.

In his comments, following the procedure set out in Article 50(1) of the REACH Regulation, the Registrant indicated his agreement to perform a study according to the OECD 107 test guideline.

Therefore, pursuant to Article 41(1) and (3) of the REACH Regulation, the Registrant is requested to submit the following information derived with the registered substance subject to the present decision: Partition coefficient n-octanol/water. Guidance for determining appropriate test methods for the partition coefficient n octanol/water is available in the ECHA Guidance on information requirements and chemical safety assessment (version 2.2., August 2013), Chapter R.7a, Section R.7.1.8.3.

IV. Adequate identification of the composition of the tested material

ECHA stresses that the information submitted by the Registrant and other joint registrants for identifying the substance has not been checked for compliance with the substance identity requirements set out in Section 2 of Annex VI of the REACH Regulation. The Registrant is reminded of his responsibility and that of joint Registrants to ensure that the joint registration covers one substance only and that the substance is correctly identified in accordance with Annex VI, Section 2 of the REACH Regulation.

In addition, it is important to ensure that the particular sample of substance tested in the new study is appropriate to assess the properties of the registered substance, taking into account any variation in the composition of the technical grade of the substance as actually manufactured by each registrant. If the registration of the substance by any registrant covers different grades, the sample used for the new study must be suitable to assess these grades.

Finally there must be adequate information on substance identity for the sample tested and the grade(s) registered to enable the relevance of the study to be assessed.

V. Information on right to appeal

An appeal may be brought against this decision to the Board of Appeal of ECHA under Article 51(8) of the REACH Regulation. Such an appeal shall be lodged within three months of receiving notification of this decision.
