# DECISION ON TESTING PROPOSAL(S)

Under Article 40 of Regulation (EC) No 1907/2006 (REACH), you must submit the information listed below by **24 April 2025**.

Requested information must be generated using the Substance unless otherwise specified.

### Information required from all the Registrants subject to Annex VII of REACH

1. In vivo mammalian alkaline comet assay also requested below (triggered by Annex VII, Section 8.4., column 2)

# Information required from all the Registrants subject to Annex VIII of REACH

2. In vivo mammalian alkaline comet assay (triggered by Annex VIII, Section 8.4., column 2; test method: OECD TG 489) in rats, or if justified, other rodent species, oral route, on the following tissues: liver, glandular stomach and duodenum.

The reasons for the decision(s) are explained in Appendix 1.

#### Information required depends on your tonnage band

You must provide the information listed above for all REACH Annexes applicable to you in accordance with Articles 10(a) and 12(1) of REACH. The addressees of the decision and their corresponding information requirements based on registered tonnage band are listed in Appendix 3.

In the requests above, the same study has been requested under different Annexes. This is because some information requirements may be triggered at lower tonnage band(s). In such cases, only the reasons why the information requirement is triggered are provided for the lower tonnage band(s). For the highest tonnage band, the reasons why the standard information requirement is not met and the specification of the study design are provided. Only one study is to be conducted; all registrants concerned must make every effort to reach an agreement as to who is to carry out the study on behalf of the others under Article 53 of REACH.



You are only required to share the costs of information that you must submit to fulfil your information requirements.

#### How to comply with your information requirements

To comply with your information requirements, you must submit the information requested by this decision in an updated registration dossier by the deadline indicated above. You must also **update the chemical safety report**, where relevant, including any changes to classification and labelling, based on the newly generated information.

You must follow the general requirements for testing and reporting new tests under REACH, see Appendix 4.

### Appeal

This decision, when adopted under Article 51 of REACH, may be appealed to the Board of Appeal of ECHA within three months of its notification to you. Please refer to <u>http://echa.europa.eu/regulations/appeals</u> for further information.

#### Failure to comply

If you do not comply with the information required by this decision by the deadline indicated above, ECHA will notify the enforcement authorities of your Member State.

# Reasons for the decision(s) related to the information under Annex VII of REACH

### **1.** In vivo mammalian alkaline comet assay

- 1 Further mutagenicity studies must be considered under Annex VII to REACH in case of a positive result (Section 8.4., Column 2).
- 2 Your dossier contains positive results for the in vitro gene mutation study in bacteria (OECD TG 471, 2016) which raise the concern for gene mutations.
- 3 ECHA considers that an in vivo follow-up study is necessary to address the identified concern.
- 4 For the assessment of the testing proposal, see Section 2.



# Reasons for the decision(s) related to the information under Annex VIII of REACH

# 2. In vivo mammalian alkaline comet assay

- 5 Appropriate in vivo mutagenicity studies must be considered under Annex VIII to REACH (Section 8.4., Column 2) in case of a positive result in any of the in vitro genotoxicity studies under Annex VII or VIII to REACH.
- 6 Your dossier contains positive results for the in vitro gene mutation study in bacteria (OECD TG 471, 2016) which raise the concern for gene mutations.

### 2.1. Information provided to fulfil the information requirement

- 7 You have submitted a testing proposal for an In vivo mammalian alkaline comet assay to be performed with the Substance.
- 8 ECHA requested your considerations for alternative methods to fulfil the information requirement for Genetic toxicity in vivo. You provided your considerations concluding that there were no alternative methods which could be used to adapt the information requirement(s) for which testing is proposed. ECHA has taken these considerations into account.
- 9 ECHA agrees that an appropriate in vivo follow up genotoxicity study is necessary to address the concern identified in vitro.

#### 2.2. Test selection

10 According to the Guidance on IRs & CSA, Section R.7.7.6.3., the in vivo mammalian alkaline comet assay ("comet assay", OECD TG 489) is suitable to follow-up a positive in vitro result on gene mutations.

#### 2.3. Specification of the study design

- 11 You proposed testing in the mouse. According to the test method OECD TG 489, rats are the preferred species. Other rodent species can be used if scientifically justified (OECD TG 489, para. 23).
- 12 You did not specify the route for testing. Having considered the anticipated routes of human exposure and adequate exposure of the target tissue(s) performance of the test by the oral route is appropriate.
- 13 In line with the test method OECD TG 489, the test must be performed by analysing tissues from liver as primary site of xenobiotic metabolism, glandular stomach and duodenum as sites of contact. There are several expected or possible variables between the glandular stomach and the duodenum (different tissue structure and function, different pH conditions, variable physico-chemical properties and fate of the Substance, and probable different local absorption rates of the Substance and its possible breakdown product(s)). In light of these expected or possible variables, it is necessary to analyse both tissues to ensure a sufficient evaluation of the potential for genotoxicity at the site of contact in the gastro-intestinal tract.

#### 2.3.1. Germ cells

14 You may consider collecting the male gonadal cells from the seminiferous tubules in addition to the other tissues in the comet assay, as it would optimise the use of animals. You can



prepare the slides for male gonadal cells and store them for up to 2 months, at room temperature, in dry conditions and protected from light. Following the generation and analysis of data on somatic cells in the comet assay, you should consider analysing the slides prepared with gonadal cells. This type of evidence may be relevant for the overall assessment of possible germ cell mutagenicity including classification and labelling according to the CLP Regulation.

#### 2.4. Outcome

- 15 Your testing proposal is accepted under Article 40(3)(a) and you are requested to conduct the test, as specified above.
- 16 In your comments to the draft decision, you agreed with the above request.

#### **Appendix 2: Procedure**

ECHA started the testing proposal evaluation in accordance with Article 40(1) on 15 February 2022.

ECHA held a third party consultation for the testing proposal(s) from 10 May 2022 until 27 June 2022. ECHA did not receive information from third parties.

ECHA followed the procedure detailed in Articles 50 and 51 of REACH.

The deadline of the decision is set based on standard practice for carrying out OECD TG tests. It has been exceptionally extended by 12 months from the standard deadline granted by ECHA to take into account currently longer lead times in contract research organisations

ECHA notified you of the draft decision and invited you to provide comments.

In your comments you agreed to the draft decision. ECHA took your comments into account and did not amend the request.

ECHA notified the draft decision to the competent authorities of the Member States for proposals for amendment.

As no amendments were proposed, ECHA adopted the decision under Article 51(3) of REACH.



# Appendix 3: Addressees of this decision and their corresponding information requirements

In accordance with Articles 10(a) and 12(1) of REACH, the information requirements for individual registrations are defined as follows:

- the information specified in Annex VII to REACH, for registration at 1-10 tonnes per year (tpa), or as a transported isolated intermediate in quantity above 1000 tpa;
- the information specified in Annexes VII and VIII to REACH, for registration at 10-100 tpa.

# Appendix 4: Conducting and reporting new tests for REACH purposes

# 1. Requirements when conducting and reporting new tests for REACH purposes

### **1.1.** Test methods, GLP requirements and reporting

- (1) Under Article 13(3) of REACH, all new data generated as a result of this decision must be conducted according to the test methods laid down in a European Commission Regulation or to international test methods recognised by the Commission or ECHA as being appropriate.
- (2) Under Article 13(4) of REACH, ecotoxicological and toxicological tests and analyses must be carried out according to the GLP principles (Directive 2004/10/EC) or other international standards recognised by the Commission or ECHA.
- (3) Under Article 10(a)(vi) and (vii) of REACH, all new data generated as a result of this decision must be reported as study summaries, or as robust study summaries, if required under Annex I of REACH. See ECHA Practical Guide on How to report robust study summaries<sup>2</sup>.

### 1.2. Test material

Before generating new data, you must agree within the joint submission on the chemical composition of the material to be tested (Test Material) which must be relevant for all the registrants of the Substance.

- (1) Selection of the Test material(s)
  - The Test Material used to generate the new data must be selected taking into account the following:
    - the variation in compositions reported by all members of the joint submission,
    - the boundary composition(s) of the Substance,
    - the impact of each constituent/ impurity on the test results for the endpoint to be assessed. For example, if a constituent/ impurity of the Substance is known to have an impact on (eco)toxicity, the selected Test Material must contain that constituent/ impurity.
- (2) Information on the Test Material needed in the updated dossier
  - You must report the composition of the Test Material selected for each study, under the "Test material information" section, for each respective endpoint study record in IUCLID.
  - The reported composition must include all constituents of each Test Material and their concentration values and other parameters relevant for the property to be tested.

This information is needed to assess whether the Test Material is relevant for the Substance and whether it is suitable for use by all members of the joint submission.

Technical instructions on how to report the above is available in the manual on How to prepare registration and PPORD dossiers<sup>3</sup>.
